PLEASE BE ADVISED THAT ALL MAIL-IN BALLOTS WILL BE COUNTED AT THE FOLLOWING LOCATION IMMEDIATELY FOLLOWING THE CLOSE OF VOTING ON AUGUST 22, 2026, AT 8:00 PM PT.

Prior to the Count Date and up until 4:00 PM on Friday August 21, 2026, you are able to hand deliver your mail-in ballot to the Electoral Officer at OneFeather: 209-852 Fort Street, Victoria, BC.

In accordance with Article 17 - each Candidate may appoint scrutineers to represent them at each Polling Station, observe the election procedures, and observe the counting of ballots. Up to two scrutineers may be appointed for the Mail-in Ballot processing and count procedures.

Candidates wishing to appoint one or more scrutineers must do so by completing the "Scrutineer Appointment Form" and providing this properly completed form to the Electoral Office **PRIOR TO** the close of the Poll.

Only Election Staff, designated MNBC Staff, Candidates and Scrutineers may be present during the processing of Mail-in Ballots, the counting of the ballots, and finalizing the election count and results. The count facilities will be accessible starting at 5:00 PM PT to begin processing the Mail-in Ballots to verify the Electors information and ensure they have not already voted. The counting of the Mail-in Ballots will not begin until 8:00 PM PT.

Finally, this count process will be live streamed. Any Candidate or Scrutineer by virtue of their presence during all or any portion of the count thereby consent to being filmed and recorded.
